GENERAL BY-LAWS

1. Sub-komitees:

Die President en Vice-President is ex-officio lede van alle subkomitees wat deur die Uitvoerende Komitee saamgestel word soos per die Konstitusie van die SSV.

2. Gaste:

Enige lid is geregtig om 'n maksimum van twee (2) gaste op 'n speeldag saam te bring onderhewig daaraan dat:

2.1. Die teenwoordigheid van die gaste geensins steurend sal wees vir ander lede nie. Dit sluit in:

2.1.1. Die gaste se spelpeil is van aanvaarbare gehalte

2.1.2. Die gasheer van die gaste sal onttrek aan spel indien daar onvoldoende spelkapasiteit is.

2.2. Hierdie gaste die toepaslike gelde en heffings sal betaal

2.3. Hierdie gaste nie meer as eenkeer per maand toegelaat sal word nie tensy 'n aansoekvorm voltooi of hangende is nie.

3. Drag:

Die drag van die SSV is soos volg:

3.1. Wit met 'n blou kraag, moue en sye soos per foto.

3.2. Skoene soos bepaal deur die reëls van Bowls South Africa.

3.3. Hoede en pette met of sonder die aanvaarde hoedband van die SSV.

3.4. Klub drag, trui en windbrekers op koue dae uitgesluit, word nie toegelaat nie.

4. Vergaderings:

4.1. Algemene Jaarvergadering: Sal eenkeer per jaar gehou word, verkieslik aan die einde van die finansiële jaar, op 'n datum wat deur die Uitvoerende komitee vasgestel sal word.

1. Sub-committees:

The President and Vice-President will be ex officio members of all sub-committees appointed by the Executive Committee in accordance with the Constitution of the SPA.

2 Guests:

Any member is entitled to bring along a maximum of two (2) guests on a playing day with the proviso that:

2.1 The presence of such guests does not inconvenience other members in any way. This includes:

2.1.1 The level of play of a guest is of an acceptable standard

2.1.2 The guests' host will withdraw from play where an insufficient play capacity exists.

2.2 That these guests will pay all monies or levies that are applicable.

2.3 Such guests will not be allowed more than once a month, unless an application form is completed or pending.

3 Dress:

The dress of the SPA is as follows:

3.1 White with blue collar, sleeves and sides as per photo.

3.2 Shoes as per laws of Bowls South Africa.

3.3 Hats or caps with or without the recognized hatband of the SPA.

3.4 Club dress, with the exception of jerseys or windbreakers on cold days, is not allowed.

4 Meetings:

4.1 Annual general meeting: Will be held once a year, preferably at the end of the financial year, on a date that will be determined by the Executive Committee.

- 4.2. Spesiale vergaderings:
- 4.2.1. Mag enige tyd gehou word deur die Uitvoerende Komitee, of
 - 4.2.2. Moet deur die Uitvoerende Komitee gehou word op 'n geskrewe versoek, geteken deur minstens twintig (20) lede, wat die rede vir die versoek vir 'n vergadering aandui.
- 4.3. Kworum: Vir beide die Algemene Jaarvergadering asook 'n Spesiale Vergadering sal twintig (20) stemgeregtigde lede 'n kworum vorm.
5. Finansies:
- 5.1. Speelgelde mag te eniger tyd gewysig word deur die Uitvoerende Komitee indien omstandighede dit vereis.
 - 5.2. Die funksie van die Tesourier sluit die volgende in:
 - 5.2.1. Voorlegging van finansiële state by die twee-maandelikse Uitvoerende Komitee vergaderings.
 - 5.2.2. Voorlegging van die volgende state by die Algemene Jaarvergadering: Inkomste en Uitgawe staat, balans staat, huidige bates en register van nie-handels bates. Hierdie state moet nagegaan word deur 'n bevoegde komitee lid of lede.
6. Advertensies of afkondigings van klub funksies:
- 6.1. Die SSV sal geen vorm van advertensie van 'n produk of funksie (Klub toernooi) toelaat onder die vaandel van die SSV.
 - 6.2. Enige versoek aan lede om elders in 'n toernooi of kompetisie te speel moet in 'n privaat of persoonlike hoedanigheid gedoen word.
7. Samestelling van verteenwoordigende spanne:
- 7.1. Die samestelling van spanne sal uitsluitlik deur die keurders gedoen word.
 - 7.2. So ver moontlik sal die sterkste spanne gekies word, om die rede sal 'n naamlys beskikbaar gestel word vir lede wat nie beskikbaar is vir sekere wedstryde of toernooie.

- 4.2 Special meetings:
- 4.2.1 May be convened at any time by the Executive Committee, or
 - 4.2.2 Must be convened by the Executive Committee on a written application, and signed by at least twenty (20) members, stating the reason of the request for a meeting.
- 4.3 Quorum: For both the Annual general meeting as well as a Special meeting twenty (20) members, with the right to vote, will form a quorum.
- 5 Finances:
- 5.1 Stakes or “tabs-in” monies may at any time be changed by the Executive Committee if circumstances justify such action.
 - 5.2 The functions of the Treasurer include the following duties:
 - 5.2.1 Submission of a financial statement to the Executive Committee at the bi-monthly meetings.
 - 5.2.2 Submission of the following statements at the annual general meeting: Income / expenditure accounts, balance sheet, current assets and register of non-trade assets. These statements must be scrutinized by a competent Executive Committee member / member.
- 6 Advertising or announcements of Club functions:
- 6.1 The SPA will not allow any form of advertisement for either a product or function (Club tournament) under the banner of the SPA.
 - 6.2 Any request to members to play elsewhere in a tournament or competition must be done in a private or individual capacity.
- 7 Selection of representative teams:
- 7.1 The selection of teams will be done exclusively by the selectors.
 - 7.2 As far as possible the strongest teams will be selected, therefore a name-list will only be provided for members who are not available for selection in certain games or tournaments.

8. Wangedrag:

In gevalle waar die gedrag van 'n lid, in die opinie van die Dagbestuur, onbehoorlik is kan so 'n lid, nadat hy 'n kans gegee is om sy saak aan die Uitvoerende Komitee te stel,

- se lidmaatskap opgeskort word of
- kan hy versoek word om binne veertien (14) dae te bedank, skriftelik met aangee van redes vir so 'n versoek.

Indien die lid nie gehoor gee aan die versoek om te bedank nie kan sy lidmaatskap onmiddellik gekanselleer word deur die dagbestuur. (Sien klousule 3.4 van die grondwet.)

9. Keuring vir SSV Meesters:

Deelname aan die SSV se meesters sal bepaal word volgens neergelegde kriteria, wat van tyd tot tyd deur die Uitvoerende Komitee gewysig kan word. Die sisteem is gebaseer op die spel rekord van spelers in interne asook eksterne senior toernooie, Enkels en Pare kompetisies.

10. Handhawing van spelstandaarde:

- 10.1. Enige speler wat nie aan die verwagte spelstandaard van senior spelers voldoen nie mag deur die keurkomitee hergradeer word.
- 10.2. Die keurkomitee mag selfs by die Uitvoerende Komitee aanbeveel dat die lid se lidmaatskap beëindig word.

8 Improper behavior:

In case the behavior of a member, in the opinion of the Management Committee, is improper such a member may, after having been given the opportunity to state his case to the Executive Committee,

- be suspended or
- be requested to resign within fourteen (14) days, in writing stating reasons for such a request.

Should a member disregard this request to resign his membership can be cancelled immediately by the Management Committee. (See section 3.4 of the Constitution).

9 Selection for SPA Masters:

Participation in the SPA's Masters will be on pre-determined criteria, which can be altered from time to time by the Management Committee. This system is based on the performance of players in internal and external senior tournaments, Singles and Pairs competitions.

10 Maintenance of playing standard:

- 10.1 Any player who does not comply with the standard of play expected from senior players may be degraded by the selection committee.
- 10.2 The selection committee may even recommend to the Executive Committee to terminate his membership.
